## 1. PGLA Fee Structure (First Payment) at the time of registration with PGLA

<b>PGLA Tuition Fee for Major Modules*</b>	Rs. 60,000/- per subject for 4 major mandatory/compulsory modules i.e., Civil Litigation, Criminal Litigation, Professional Ethics & Advocacy (Civil Appl., Examination In Chief & Cross Examination)
<b>PGLA Tuition Fee for Extra Modules</b>	Rs. 20,000/- per subject for 4 optional modules (subject to your BSB Exemption Letter) i.e., Opinion Writing, Legal Research, Conferencing Skills, Drafting
<b>PGLA Fee for BSB Application*</b>	Rs. 60,000/-* Registration with BSB, creating an account, Guidelines as to filling up the application form, submitting the appropriate documents & guidelines on Professional Statement (if applicable).
<b>TOTAL PGLA FEE*</b>	Rs. 300,000/- per candidate (4 Major Compulsory Modules only & Application Fee)*

Please note that the above given fee structure is only valid for January 2023 Intake with PGLA & doesn't include the fee payable to BSB, Lincoln's Inn & the BPP University. \*

## 2. Bar Standards Board (BSB)\* (Second Payment)

Application Fee: £440\*

Please note that once a candidate has paid the tuition fee, he/she will be able to attend the classes for 4 major compulsory modules. PGLA intends to compile & forward your applications to BSB in the last week of February 2023. As such a candidate needs to pay £440 to BSB at that time. \*

## 3. The Honourable Society of Lincoln's Inn\* or in any of the Four Inns of the Court (Third Payment) approximately after 1.5/2 months or as soon as a candidate is granted his/her exemptions from BSB.

Registration Fee: £121

## 4. BPP University, London (Fourth Payment)

All the candidates who fulfil the aforesaid procedure can apply in BPP University for assessments which would take place in three sessions (March, August & December) \*<sup>1</sup>
