Seeking Exemptions

The Bar Standards Board (BSB) may grant full or partial exemption from some or all the components of the Bar Training i.e., Academic & Vocational Training (Part A & B). Your applications for exemption will be assessed according to your academic and professional qualifications, your employment and/or practicing experience, your rights of audience, and your 'Good Standing'. These exemptions may further be subjected to your BSB's Professional Statement.

Modules/Curriculum

The Part B - The Vocational/Professional Stage of the Bar Training contains eight (8) modules. However, the Bar Standards Board may exempt some of the components of the Vocational Stage, subject to your previous experience and practice:

- Civil Litigation & Evidence (Major)
- Criminal Litigation, Evidence & Sentencing (Major)
- Professional Ethics (Major)
- Civil & Criminal Advocacy (Major)
- Opinion Writing
- Legal Research
- Drafting
- Conferencing Skills
